1. WHO DOES THIS NOTICE APPLY TO?

- 1.1 This Notice applies to you, as a user of our website.
- 1.2 In this Notice references to:
 - 1.2.1 **we, us** or **our** means **Saint John of God Hospitaller Services** (company number 05324279 and charity number 1108428) with its registered address at Suite 1-3 Yarn,Lingfield House, Lingfield Point, Darlington, Co Durham, DL1 1RW;
 - 1.2.2 **personal information** is information that is about you and which identifies you; and
 - 1.2.3 **processing** (and **processed** and **process**) includes collecting, recording, altering, retrieving, storing, using, disclosing or destroying.

2. WHAT IS THE PURPOSE OF THIS NOTICE?

- 2.1 We are committed to ensuring that your privacy is protected and that we comply with all applicable data protection laws (including the General Data Protection Regulation, which is otherwise known as "the GDPR") as controller of your personal information and when processingyour personal information.
- 2.2 The purpose of this Notice is therefore to explain, for example:
 - 2.2.1 **what** personal information we collect about you;
 - 2.2.2 how we will **use** and **share** your personal information;
 - 2.2.3 how long we will **keep** your personal information;
 - 2.2.4 the **rights** that you have in relation to your personal information; and
 - 2.2.5 how you can **contact us** about this Notice.

3. WHAT PERSONAL INFORMATION MAY WE HOLD ABOUT YOU?

- 3.1 We will only collect, use and retain personal information about you that we believe we require.
- 3.2 We will not collect, use or retain personal information about you "just for the sake of it".
- 3.3 We may process different kinds of personal information about you which we have collected fromour website and which we have grouped together as follows:
 - 3.3.1 **Identity Data** includes first name, maiden name, last name, username or similaridentifier, marital status, title, date of birth and gender.
 - 3.3.2 **Contact Data** includes home address and e-mail address.
 - 3.3.3 **Financial Data** includes bank account and payment card details.
 - 3.3.4 **Transaction Data** includes details about payments from you and other

details ofservices you have purchased from us.

- 3.3.5 **Technical Data** includes internet protocol (IP) address, domain name, operating system, your login data, browser type and version, time zone settings and location,browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access this website.
- 3.3.6 **Profile Data** includes your username, password and your feedback.
- 3.3.7 **Usage Data** includes information about how you use our website, the website that referred you to us, the files you download, the pages viewed and the times and datesof these visits.
- 3.4 We do not collect any **special categories of personal information** about you (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinion and information about your health) or any information about criminal convictions and offences through our website, unless you provide that information to us. We ask that you do not provide us with any special categories of personal data via our website unless you consider itnecessary to do so.

3.5 If you fail to provide personal information

Where we need to collect personal information by law, or under the terms of a contract we have with you, and you fail to provide that information when requested, we may not be able to performthe contract we have or are trying to enter into with you. In this case, we may have to cancel a service you have with us but we will notify you if this is the case at the time. If you are a user of our services please refer to our service user privacy notice to find out more about how we use your data.

4. HOW IS YOUR PERSONAL INFORMATION COLLECTED?

- 4.1 We use different methods to collect personal information from and about you including through:
 - 4.1.1 **Direct interactions.** You may give us your personal information when, for example:
 - (a) sending us an e-mail via the "Contact Us" section of our website;
 - (b) enquire or apply for our services;
 - (c) create an account on our website in order to apply for a job vacancy; or
 - (d) give us feedback or contact us.
 - 4.1.2 **Automated technologies or interactions.** As you interact with our website, we will automatically collect Technical Data about your equipment, browsing actions and patterns. We collect this personal data by using cookies, server logs and other similartechnologies. We may also receive Technical Data about you if you visit other websites employing our cookies. Please see our cookie notice for further details.
 - 4.1.3 **Third party or publicly available sources.** We will receive personal data about youfrom various third parties as set out below:

- (a) Technical data from the following parties:
 - (i) analytics providers such as Google based outside the EU;
 - (ii) [any others such as search information providers?]
- (b) Contract, Financial and Transaction Data from providers of technical, paymentand delivery services such as Just Giving based inside the EU.

5. HOW DO WE USE AND SHARE YOUR PERSONAL INFORMATION?

- 5.1 We process personal data to enable us to further our charitable objects which are broadly:
 - 5.1.1 The relief of poverty, sickness, old age, distress and disabled persons; and
 - 5.1.2 To further the charitable purposes for the time being of Hospitaller Order of Saint Johnof God Charitable Trust.
- 5.2 Your personal information may be used by us (including our staff), and disclosed to third parties (including the third parties from whom we receive your personal information). For each of the purposes we have set out the legal basis on which we use and share your personal information inthe table below.

6. HOW CAN YOU MANAGE COOKIES?

6.1 You can set your browser to refuse all or some browser cookies, or to alert you when websitesset or access cookies. If you disable or refuse cookies, please note that some parts of this website may become inaccessible or not function properly. For more information about the cookies we use, please see our cookies notice.

7. HOW LONG WILL WE KEEP YOUR PERSONAL INFORMATION?

7.1 We will keep your personal information for as long as is necessary for the purpose for which we collect it. The exact period will therefore depend on the purpose for which we hold your personalinformation. For example, where we hold personal information:

- 7.1.1 To comply with a legal or regulatory obligation, we will keep that information for at leastas long as is required to comply with that obligation.
- 7.1.2 To deal with a complaint that you have raised, we will keep the information for a periodof seven years following resolution of the complaint in accordance with our complaints procedure or following conclusion of our complaints procedure (whichever is earliest).
- 7.1.3 To provide services for you, we will keep the information in accordance with the termsof our privacy notice for service users.
- 7.1.4 To access your application for a job with us, we will hold that information in accordancewith our privacy policy or job application.
- 7.1.5 To help to improve our services, we will hold your personal information for at least aslong as required to design, implement and monitor any such improvements.
- 7.2 We may extend the period for which we keep your personal information in the event that legal proceedings are brought in relation to or involving you. In those circumstances we may need to retain some relevant personal information for as long as is necessary for the purposes of such litigation.

8. DO WE SEND YOUR INFORMATION OUTSIDE THE EUROPEAN ECONOMIC AREA ("EEA")?

- 8.1 Some of our external third party providers are based outside the EEA so their processing of yourpersonal data will involve a transfer of data outside the EEA.
- 8.2 Whenever we transfer your personal data out of the EEA, we ensure a similar degree of protection is afforded to it by ensuring appropriate safeguards are in place, for example:
 - 8.2.1 We will only transfer your personal data to countries that have been deemed to provide an adequate level of protection for personal data by the European Commission.
 - 8.2.2 Where we use providers based in the US (e.g. Google Analytics), we may transfer datato them if they are part of the Privacy Shield which requires them to provide similar protection to personal data shared between Europe and the US.

9. HOW SECURE IS THE PERSONAL INFORMATION THAT WE COLLECT ABOUT YOU?

- 9.1 We have put in place appropriate security measures to prevent your personal information frombeing accidentally lost, used or accessed in an unauthorised way, altered or disclosed.
- 9.2 We also limit access to your personal information to those employees, workers, agents, contractors and other third parties who have a business need-to-know. They will only processyour personal information on our instructions and will be subject to a duty of confidentiality.
- 9.3 We have processes in place to ensure that any personal information that we keep in hard copyform is stored securely.

9.4 Where we keep personal information in soft copy, that is stored either on our secure AC_152594608_1

servers oron secure servers operated by a third party.

- 9.5 Please note that the transmission of information via the internet is not completely secure. Although we will do our best to protect your personal information transmitted via our website, wecannot guarantee the security of your personal information transmitted in this way and any transmission is at your own risk. Once we have received your personal information, we will use strict procedures and security features to try to prevent unauthorised access.
- 9.6 We have put in place procedures to deal with any suspected data security breach and will notifyyou and any applicable regulator(s) of a suspected breach where we are legally required to do so.

10. WHAT ARE YOUR RIGHTS IN RELATION TO YOUR PERSONAL INFORMATION?

10.1 You have certain rights in relation to your personal information. Those apply in certaincircumstances and are subject to certain exemptions. In summary, those rights are:

The Rights	Summary of Your Rights
Right of access to yourpersonal information	You have the right to receive a copy of your personalinformation that we hold about you.
Right to rectify your personal information	You have the right to ask us to correct the personal information that we hold about you where it is incorrect orincomplete.
	If any of the personal information that we hold about you changes then we encourage you to please let us know assoon as possible so that we can ensure our records aboutyou are accurate and up-to-date.
Right to erasure of yourpersonal information	You have the right to request that we erase all information we hold about you if the information is no longer being usedfor the purposes you have consented to or if you revoke anyconsent given to us processing that information.
Right to restrict the use ofyour personal information	You have the right to request that we suspend our use of your personal information in certain circumstances.
Right to data portability	You have the right to request that we copy or transfer your personal information to another service provider.
Right to object to the useof your personal information	You have the right to object to the use of your personalinformation.
Right to withdraw consent	You have the right to withdraw your consent at any timewhere we rely on consent to process your personal information.

Right to complain to
the data protection
regulatorfor England
and Wales

You have the right to complain to the Information Commissioner's Office (otherwise known as the "ICO") whereyou think we have not used your personal information in accordance with data protection law.

11. WHAT DO WE DO WITH INFORMATION ABOUT CRIMINAL CONVICTIONS ANDOFFENCES?

- 11.1 We do not routinely process personal data relating to criminal convictions and offences.
- 11.2 If and when we do process such data about you, we will only do so where you have provided your consent, or where we consider it necessary to protect your vital interest or where necessaryin relation to legal claims. When processing such information we will ensure that appropriate safeguards are in place.

12. WHAT OTHER INFORMATION SHOULD YOU BE AWARE OF?

12.1 This website includes links to third party websites, plug-ins and applications including, for example, to the Just Giving UK site, our Facebook page, the websites of certain religious organisations (e.g. Catholic Online) and various care and advice websites (e.g. the CQC, and Carers UK). Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control those third party websites and are not responsible for their privacy statements. When you leave our website, we therefore encourageyou to read the privacy policy of every website you visit.

13. WHEN AND HOW CAN WE MAKE CHANGES TO THIS NOTICE?

13.1 We may update this Notice at any time. The changes will come into effect once the updatedNotice is published on our website.
